Role Overview

The Sandhurst Mission and Pastoral Council exercises leadership under the authority of the Bishop by investigating, considering and proposing practical priorities and strategies relating to the mission and pastoral life of the Diocese. The Council seeks out and listens to the voices of the faithful in the local Church and all people in this part of regional Victoria, and is committed to dialogue, reflection, discernment and action. The Council is an advisory and consultative body that works in partnership with other diocesan advisory bodies and Catholic entities to support the Bishop and other groups in their local church leadership roles (Sandhurst Mission and Pastoral Council, *Statutes* §1).

Engagement

Members are appointed to the Sandhurst Mission and Pastoral Council by the Bishop in accordance with Canon §512. Appointment to the Council is for a period of three years, with the possibility of renewal for a further three years. Members of the Council must have attained the age of 18 years.

Key Undertakings

- 1. Attend all meetings of the Sandhurst Mission and Pastoral Council.
- 2. Commitment to synodality.
- 3. Contribute to developing, monitoring, and evaluating the Diocese's strategic direction, through a process of ongoing listening, dialogue and discernment.
- 4. Undertake consultative processes with the deanery and/or the community base from which the Member is called.
- 5. Undertake tasks and participate in working groups between meetings of the Council.

Knowledge, Skills, and Experience

- Leadership capability
- An understanding of and a commitment to promoting the principles of Catholic Social Teaching and Gospel values.
- Communication and organisational skills of a high order.



Accountability (Independence and Influence)

Members of the Sandhurst Mission and Pastoral Council:

- Support and advise the Bishop of Sandhurst on the mission and pastoral life of the diocese.
- Consult with and provide reports to parishes, schools, deaneries and other diocesan entities, bodies and groups.
- Assist in and contribute to the review of the function and operation of the Sandhurst Mission and Pastoral Council.
- Complete mandatory training as required.

Safety of Children and Vulnerable Adults

- Promote and implement occupational health and safety and risk mitigation processes within your workgroup.
- Comply with Diocesan occupational health and safety practices.
- Identify, report and where appropriate, action risks/hazards, to eliminate or mitigate against the risk recurring.
- Participate in the consultative processes provided by the organisation.
