For bequests of personal property or real estate appropriate descriptions would be required.

HOW CAN I ARRANGE A BEQUEST?

HOW DO I MAKE A BEQUEST BY WILL?

The Foundation is a registered deductible gift recipient (DGR) allowing tax deductibility for donations if required. Should you require tax deduction please nominate the DGR account and provide your name and address so we can forward a receipt. The suggested wording to seek a tax deduction for your donation of bequest is as follows: "I give to the Priests Retirement Foundation Diocese of Sandhurst (ABN 38 842 127 107) to provide financial assistance to Priests in necessitous circumstances free of all duties."
